## If you are applying for Rental Housing

A complete application includes the following:

- ✓ Current applicant contact, household, financial and credit information. (You should write N/A if a question does not apply to you.)
  - ✓ A government issued photo ID or other acceptable form of verification of identity.
  - ✓ Income Documentation:
    - Three most recent pay stubs and/or benefit statements for all adult household members
    - Your most recent Federal Tax Return and tax ID or social security number (or an explanation for why you have not filed) for all adult household members
    - A recent credit report with a credit score for all potential household leaseholders
  - ✓ If you are qualified and chosen as a potential tenant, NCLT may ask for a \$25.00 credit check fee, payable to NCLT. You will receive a copy of this report for your records.
